Housing association United Welsh has appointed Richard Mann as its new group chief executive.

Caerphilly-based United Welsh currently provides more than 6,300 homes across south Wales and plans to build 1,300 more in the next five years.

Mr Mann, currently the housing association's deputy chief executive and group director of operations, will take over the post from Lynda Sagona next month. Ms Sagona is standing down after five years in the role and working for the organisation since 2009.

Chief strategy officer of Cardiff-based broadband network provider Ogi, Giles Phelps, is stepping back from his role in the new year to focus on developing new business ventures, including renewable energy company Tewdric Energy.

In 2020, Mr Phelps was part of the team that helped secure landmark investment from leading infrastructure investors, Infracapital, in the Spectrum Fibre portfolio of companies. The investment is one of the largest secured by a Welsh tech business in recent years and will deliver an ambitious plan to bring full-fibre connectivity to communities across south Wales. Through the funding, the aim is to grow the business into one of Wales' leading broadband providers and help accelerate Wales' digital transformation.

A new senior management team was put in place last year to deliver the plan, and in the last 12 months the company has grown from a team of 20 to over 100 staff members, been rebranded as Ogi and started to connect new customers from Pembrokeshire to Monmouthshire.

Mr Phelps said: "A year on from our landmark investment, I am confident that Ogi is in a very strong position for the future. The business has solid backing, firm foundations and fresh ambition. I'm excited to watch Ogi's continued growth, as I shift my focus to building up a new venture, in a new sector."
